- ATTENDANCE** – Starting 01 January your attendance will be reviewed quarterly instead of annually. NSCC Regulations state that you must attend 75% of all scheduled drills. That is four of six drills per quarter. If you do not meet this minimum standard, you will be administratively warned. If you continue to fail to meet minimum attendance standards, you will be discharged from the NSCC/NLCC.
- COURSEWORK** - All Cadets are required to turn in at least one (1) coursework assignment per drill. A reminder to those Cadets who have successfully completed Recruit Training. Your advancement to E-2 will be delayed until your completion of the BMR. Please speak with the Training Officer, if you have any questions.
- ENROLLMENT FEES** - The cost of re-enrollment is \$53.00 for both NSCC and NLCC. If you are coming up on your re-enrollment date, please ensure you coordinate with the Personnel Officer in the Admin Office.
